

The budget summary is a condensed projection for the 2023 revenue and expenses.

2023 Annual Assessment Increase Notice

- The WaterView Annual Assessment will be \$742.50, an annual increase of \$67.50.
- The Broadmoor Semi-Annual Assessment will be \$346.50 (\$693.00 annually), an annual increase of \$63.00.

The Board deemed the adjustments to the assessments necessary to keep pace with market increases in the cost for goods and services required to maintain and improve the community.

Over the last 10 years, the WaterView Assessments have increased 10% every 5 years.

- Past 2012: \$561
- **2013 2017: \$617**
- **2018 2022: \$675**
- **2023:** \$742.50


Most Commonly Addressed Violations

Violation Enforcement Policy

- 1. First Violation Letter 10 days to comply
- 2. Final Notice 10 days to comply
- 3. TROPA Notification (certified) 30 days to comply (Owners are assessed a \$10 fee for this notification)
- 4. Fine Process First day initial fine of \$25.00 is assessed and \$10.00 per day until violation is cured.


